Hello! My name is **Rohan Sharma**. I am 15 years old and a sophomore at Whitney High School in Rocklin. I recently won the "Eleanor Stem Allen Memorial Speech Trek Contest" for the Roseville-South Placer Branch. This was my first time participating in the contest, and the reason I signed up was not because of the cash prizes, but because I enjoy public speaking and want to improve my oratory skills as much as I can. I am interested in becoming a civil rights attorney and entering public service later in



my life, so the public speaking skills I am developing now will serve me well in the future.

Another reason I entered the contest and dedicated myself to creating and delivering the best speech I could, is because of the topic. Standing up to sexism is something I believe is a pressing issue in society today, and something I wanted to share my beliefs and solutions on, so I am grateful I had the opportunity to do so. I learned that researching, working, and speaking on an issue I am passionate about is not a dreary task, but rather a rewarding one. The money I earned from the contest, however, will help me towards attaining my dream of attending Stanford University.

Women of Distinction 2018 was a Great Success! By Sue Miller, WOD Event Chair

The third annual Women of Distinction fundraiser in support of our community programs took place March 8 at the Catta Verdera Country Club, bringing together branch and community members in a gala evening. Honorees Dawn Clayton, General Manager of the Thunder Valley Casino and Resort and Susan Rohan, Mayor of Roseville, shared interesting stories about their



work. Dawn noted that, while working as a dealer in a casino, she entered college and earned a degree, and supports our branch giving scholarships to re-entry women. Susan encouraged women to consider running for office. A number of elected officials, including Placer County Supervisors Jim Holmes and Kirk Uhler, Roseville Vice Mayor Bonnie Gore, Lincoln City Council Member Paul Joiner, and five members of the Sierra College Board of Trustees joined in celebrating the Honorees.

Speakers Nancy Kirshner-Rodriguez, former Executive Director of the California Commission on the Status of Women, and Beth Broome, Adviser on STEM to the Provost at UC Davis, spoke about their work focused on improving the lives of women and girls, and how it connects with AAUW's mission. After the passage of the Pay Equity legislation in 2016, Nancy established a Status of Women Committee on Pay Equity, tasked with developing the implementing regulations. Beth is active in Million Women Mentors, women in STEM fields who work with young women pursuing education and careers in science, technology, engineering and math. Both our honorees and speakers complimented Roseville-South Placer branch for the many ways it supports women and girls through scholarships and educational programs.

Through extensive committee efforts, Women of Distinction has been successful, not only in raising funds, but in raising awareness in South Placer about AAUW. Our branch's membership in the Roseville and Rocklin Chambers of Commerce has helped many in the community learn of AAUW's commitments to better the lives of women and girls. This inspired Honoree Dawn Clayton and Thunder Valley to make generous donations at the event! Building a broader base of support will ensure that we can continue and even expand our outreach in South Placer County.

Why is Title IX Important? By Sue Miller, Public Policy Chair



You may be wondering, "Why is Title IX a big deal to AAUW?" Or thinking, "Girls have it made now, they have girl's athletic fields and locker rooms, etc."

Consider this: Title IX of the Education Code, passed in 1972, is the first comprehensive federal law to prohibit sex discrimination

in education. It covers women and men, girls and boys, and staff and students in any educational institution or program that receives federal funds. This includes local school districts, colleges and universities, for-profit schools, career and technical education agencies. Title IX enforcement is centered in the Office of Civil Rights (OCR) in the U.S. Department of Education, which works through state education departments on some aspects of enforcement.

By prohibiting hostile, threatening, and discriminatory behavior, Title IX protects the rights of all students to learn. Girls and women have made great strides in education under Title IX. Girls now have greater opportunities to participate in sports. The proportion of girls in STEM fields is growing as schools increase outreach and retention programs and address gender bias.

Despite progress, challenges to equality in education still exist. Pregnant and parenting students are still placed in continuation schools rather than being accommodated in mainstream classes. Schools are required to have Title IX coordinators, but many do not. A 2016 AAUW study of U.S. Civil Rights Data Collection statistics on schools reporting harassment and bullying showed that 68 percent of districts reported zero allegations of sexual harassment or bullying. The high rate of zeros points to very real problems in school reporting systems. And, if such incidents are not reported, they are likely not being addressed.

For decades students and advocates have called on OCR to enforce the Title IX statute, regulations, and Supreme Court case law concerning sexual harassment and violence, protections for pregnant and parenting students, equity in career and technical education, athletics, transgender students, and more. Under the previous administration, OCR issued periodic guidance documents clarifying how educational institutions should address issues. However, in the past year Secretary of Education Betsy DeVos has undertaken an effort to reduce the protections of Title IX, most recently to roll back protections for survivors of sexual assault.

With progress under threat, AAUW members must be ready to make our voices heard. Come to the Branch meeting on April 5 to hear Alicia Hetman discuss what can be done to assure that the protections guaranteed in Title IX remain strong and are enforced.

Accompanying them will be Nia Sanders from Silverado Middle School; Ella Zumot from Cavitt Middle School; Sydney Hurter from Olympus Middle School; Brooke Roeker from Glen Edwards Middle School; and finally, Alyssa Rizzardo from Twelve Bridges Middle School. Changes—and Time to Renew AAUW Membership

As we prepare for fiscal year 2019, there are a lot of changes happening at AAUW.



The AAUW Board of Directors voted in June 2017 to enact the first dues change in almost a decade. Effective March 16, 2018, **national dues will increase from \$49 to \$59**.

Annual dues currently account for 13 percent of AAUW's annual budget. They help to sustain and grow AAUW's programs and work that advances equity for women and girls. A combination of dues, donations, and corporate and foundation funding is critical to supporting AAUW's salary negotiation workshops, groundbreaking research, advocacy efforts, campus leadership programs, and so much more.

State and local dues stay the same: \$20 for State and \$24 for our local Branch. A total of \$103 for the coming 2018-2019 year.

AAUW is aiming high in the strategic planning process on which it has just embarked, undertaking an ambitious, rigorous course of action that will sharpen our focus, relevance, and impact and buttress our core issues — pay equity, education, STEM (science, technology, engineering, and math), leadership, and Title IX — to solidify AAUW's position as a leader within the equity space during the 21st century.

The process involves asking these questions: Where are we now? Where do we want to be? How will we get there? And it involves integrating our mission, programs, and business model. "We're going to need rigorous focus and meaningful relevance in order to achieve lasting impact with respect to our mission," says Churches (Chief executive officer Kimberly Churches). "We're about advancing equity, but what are we doing to ensure that we are demonstrating measurable impact? This is a new planning process, but it's more than a plan. It's about the outcomes we will achieve and how we implement them."
